Dear members,

One question we ask ourselves at OneAZ is how we can improve the lives of the communities where our members live and work. In 2023, we're answering that question by increasing our commitment to supporting nonprofit organizations in your neighborhoods.

That commitment starts with our Community Impact Grant program. Applications for Community Impact Grants are now open through April 21st. This year, 60 local nonprofit organizations will receive \$5,000 grants — a total of \$300,000 in giving! So, if you know of an Arizona-based nonprofit, please encourage them to apply for a OneAZ Community Impact Grant!

The reason we're able to give back at such a high level is because of our members. Each time a member swipes their OneAZ debit card, we donate one cent to the Foundation, which in turn puts that money right back into your communities. One cent may not seem like a lot, but this year it's allowing us to pledge \$500,000 to local causes.

Giving back to locally based nonprofits is one of the unique benefits of a community credit union like OneAZ. Another is having a voice in how your financial institution conducts business. You are empowered to help drive the direction of OneAZ through our annual board elections. This year's elections recently wrapped up and we will announce the results at our Annual Meeting on April 11th. We encourage all members to join us virtually or in person to celebrate our 2022 achievements and see what we have planned for 2023.

Thank you for trusting OneAZ with your financial future. It is an honor to serve each and every one of our members.
